



Addendum to the notice for the issue of the Bidding Documents

## Development, Operation and Maintenance of a Super-Specialty Hospital on Public Private Partnership Mode in Patna, Bihar (“Project”)



Health Department, Government of Bihar ("Authority") issues an amendment to the notice issued by it on 13 December 2014 vide PR-No-9735 (13-14) inviting Bidders to purchase the Bidding Documents to participate in the bidding process for the selection of a private player through global competitive bidding process for implementation of the Project.

Capitalised terms used but not defined in this Addendum, shall have the meaning given to them in the Notice (as defined below).

The Authority, pursuant to notice dated 13 December 2014, released on the Authority's website <http://www.health.bih.nic.in>, invited prospective Bidders to purchase Bidding Documents to participate in the bidding process for selection of a private player through global competitive bidding process for implementation of the Project (the "Notice"). Subsequently, pursuant to a notice dated 17 January 2015, released on the Authority's website, the prospective Bidders were invited to attend a Pre-Bid Conference and a site visit scheduled on 19 January 2015.

**Sale of Revised Documents:** The Bidding Documents have been revised based on the queries and suggestions received by the Authority from the prospective Bidders during the Pre-Bid Conference and by email. The addendum setting out the amendments and modifications made to the Bidding Documents, the revised Bidding Documents and the responses to the Bidder queries (together, the **Revised Documents**) are available for sale in the manner set out in the Notice. For the avoidance of doubt, it is clarified that all Bidders who are registered Bidders as of the date of this Notice are not required to purchase the Revised Documents, which will be sent to them by the Authority on their notified e-mail addresses. However, the Authority will not be responsible for non-receipt of any Revised Document by the prospective Bidders on account of incorrect e-mail addresses provided by them.

**Extension of period for submission of applications and revised Bid Due Date:** The time period set out in the Notice for submission of the application, along with the document fee, was during office hours from 15 December, 2014 to 12 January, 2015. This period has now been extended up to **3<sup>rd</sup> June, 2015**.

Further, the revised Bid Due Date (as defined in the Bidding Documents) is **4<sup>th</sup> June, 2015**.

Save as amended hereby, the Notice shall continue in full force and effect in accordance with the terms thereof.
