



to Article-309 of the Constitution of India, The Governor of Bihar is pleased to make the
following amendments in "Senior Resident / Tutor and Bihar Medical Education Service
recruitment, appointment & promotion Rules-2008:-

AMENDMENTS

1. After clause (iv) of sub rule (a) of rule -9 of chapter -6, the following new clause (v)
shall be added :-

“(v) The determination of pay scale of pay under Dynamic A.C.P. to those teachers of
Bihar Medical Education Service, who have been appointed as Asstt. Professor or who,
immediately prior to joining this service, had served continuously as a member of the Bihar
State Health Service, shall be made taking into account the total service rendered. As a result,
Assistant Professors shall be eligible for financial upgradation in the scale of pay of Associate
Professor on completion of total 12 years of continuous service and in the scale of Professor
on completion of total 18 years of continuous service, subject to fulfilling other conditions. ”

2. This Notification shall come into force at once.


