Amendment of Notification

WHEREAS, vide notification no. 26(15), dated- 14.01.2019, in exercise of powers conferred under FSS Act, 2006 to prohibit, storage, distribution, transport or sale of fishes was prohibited within the **territorial jurisdiction of Patna Municipal Corporation** in the interest of public health.

WHEREAS, several representation from public, traders and other sections were received thereafter with a request to grant the permission for exempting the sale of live fishes.

THEREFORE, after careful consideration and deliberations the aforesaid order is modified to the extent that transport, storage, distribution or sale of **only live fishes** is hereby allowed in notified fish markets (Mandis) of Patna Municipal Corporation till further orders.

Rest of the portion of the aforesaid order shall be as notified earlier.
